RULES AND REGULATIONS

Registration without a signed indemnity agreement will not be processed, and dogs will not be able to participate in the race.

Shot Records are required. Send a copy of shot records with registration. If you register on site, you will need to bring a copy of the shot records to be kept with the registration form. Registrations without shot records will not be assigned to a race until records are received.

All dogs must have current shots.

Races for the small dogs will begin at 11:30 am. All dogs will race in a preliminary race. Preliminary times will be used to randomly assign the fastest dogs to the quarterfinal races.

Must be a Wiener Dog. – This does not mean they have to be AKA registered. If their shot record from the vet indicates breed of dog as dachshund, - then it is a wiener dog. No mix breeds will be allowed. The event organizers have the right to disqualify any dog if there is a question of the breed.

You may bring your dog's favorite toy. (Toy may not be bigger than 8 inches).

No food (human or dog food) or other pets are allowed in racetrack area.

All dogs **MUST** be on a leash and must be controlled by an adult.

Owners are required to clean up their dog's waste. Bags and waste receptacles will be provided. Should an owner be seen not cleaning up after their dog, the event organizers have the right to disqualify the dog.

Dogs should be on their best behavior (i.e. no fighting, biting or aggressiveness). If a dog is exhibiting aggressive behavior, it may be disqualified or be removed from the race area at the sole discretion of the event organizers.

Only one owner/handler allowed in the racetrack area. No waving blankets or other large items at the start of the race.

Weight categories and race times may be changed at the event organizers' discretion.

RELEASE, WAIVER, AND INDEMNIFICATION

I, the undersigned, wish to participate in the 1st Annual Wienie Run sponsored by the City of Tehachapi ("City") at the Annual Hot Dog Festival on July 4, 2009 (the "Activity"). I understand that the Activity will include dog races in an enclosed track and will create the risk of contact between dogs and possible dog fights, injuries to dogs and to dog owners or others assisting with the Activity.

THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE CITY OF TEHACHAPI, ITS OFFICERS, COUNCIL MEMBERS, COMMISSIONERS, EMPLOYEES, AND AGENTS (hereinafter referred to as "Releasees") from all liability to the undersigned, the undersigned's personal representatives, assigns, heirs, and next of kin for any loss, damage, or claim therefor on account of injury, death, or damage to the person or property of the undersigned including, without limitation, the undersigned's dog or dogs, whether caused by any act or omission of the Releasees or otherwise while the undersigned is participating in the Activity or using any City facilities in connection with the Activity.

THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY, DEFEND, AND HOLD HARMLESS the Releasees from all liability, claims, demands, causes of action, charges, expenses, and attorney's fees arising out of, relating in any way to, or resulting from any act or omission of the undersigned while participating in the Activity and whether caused in whole or in part by an act or omission of the Releasees or otherwise.

The undersigned is aware of the provisions of Section 1542 of the California Civil Code which reads as follows and hereby waives his or her rights for his or herself thereunder: "A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

The undersigned acknowledges and agrees that the City shall have complete discretion on whether or not any dog, including the undersigned's dog, may participate in the races and the City may disqualify any such dog in its sole discretion. The undersigned further acknowledges that the undersigned will provide the shot records for the undersigned's dog and hereby represents and warrants that the shot records that the undersigned will provide are true and correct and represent the shots and the dates of same that have been received by the undersigned's dog.

I AM AWARE THAT THIS IS A RELEASE AND WAIVER OF LIABILITY AND AN INDEMNITY AGREEMENT AND A CONTRACT BETWEEN MYSELF AND THE CITY OF TEHACHAPI AND SIGN IT OF MY OWN FREE WILL.
